## BOX SCORE on House and Senate Progress through October 12, 2015 Call for Concurrent Action on the Part of Our Divisions

### 1. FINALLY, WITH S.2091, WE NOW HAVE MIRROR-IMAGE VISA WAIVER FOR POLAND LEGISLATION IN THE UNITED STATES SENATE WHICH WE DID NOT HAVE DURING THE 113TH CONGRESS (2013-2014)

It is well to remember that legislation submitted by the United States Congress to the President for enactment into Public Law requires that duplicate pieces of legislation -- reflected in title and substance, with the only exception being different bill numbers reflecting their House and Senate origins -- be passed both by the House of Representatives and the Senate.

This crucial second piece of legislation became a reality thanks to Senator Charles E. Schumer -- with whom our Council of National Directors met amicably and intimately in the Cannon House Office Building on Capitol Hill on July 22, 2015 -- who went on to introduce S.2091 (JOLT Act of 2015) on September 29, 2015. As of the moment, it has attracted 15 co-sponsors, with those from states in which we have Divisions indicated in red, as follows:

It is worthy of note that "all questions are to be decided on the Senate floor by simple majority vote unless a constitutional provision or Senate rule or precedent provides otherwise. A simple majority vote is defined as at

least 50% plus one of the Senators voting, provided that a quorum is present." In the Senate, the quorum is 51. The only exception to the foregoing is when "the Constitution requires a two-thirds vote of the Senate to

- expel a Senator,
- override a presidential veto,
- adopt a proposed constitutional amendment,
- convict upon impeachment,
- give the Senate's advice and consent to ratification of a treaty,
- determine that a president remains disabled, and
- remove political disabilities (now obsolete)."

In short, ladies and gentlemen, with the current 15 co-sponsors as a foundation, there is good probability that S.2091 will be passed in the Senate provided that we vigorously lobby our Senators on Capitol Hill to sign on as co-sponsors as well. We have the balance of this year and nearly all of the 2nd Session of the 114th Congress next year to accomplish our objective in the United States Senate. Let's work to bring this matter to a successful conclusion by the end of July 2016 which, in effect, will serve as a model of bipartisan action to encourage the House of Representatives to act similarly on the matter of H.R.1401 as well.

Please remember that in contrast with the House of Representatives where you can only establish contact the Congressman/woman in whose Congressional District you reside, in the Senate you can contact both of your state's U.S. Senators. When contacting the Senate offices of the two involved Senators in your state, please read the following message in a clearly-enunciated and an equally-unrushed manner:

"I am ( **fill in your name and residential address** ), a Polish American voting constituent of United States Senator ( **fill in his or her name here** ). It is of great importance to me that he/she will consider becoming a co-sponsor of S.2091 (JOLT Act of 2015) which was introduced in the Senate by Charles Schumer of New York, and which is making impressive progress in attracting co-sponsors. Among the many provisions of S.2091 is one that will enable Poland, a loyal friend and ally of the United States, to be admitted to our nation's Visa Waiver Program. If Senator ( **fill in his or her name here** ) decides to co-sponsor this legislation in the Senate, it will serve as a clear demonstration of his/her commitment to this legislation that I and his/her other Polish American voting constituents will welcome and remember. Please inform him/her of my message at your earliest convenience. Thank you."

In addition, let's not encourage our relatives, friends, and business associates in states not having Divisions of the Polish American Congress to support this effort by contacting their own United States Senators.
